

Privacy policy for use of the coronavirus test platform for administering rapid tests.

This privacy policy informs you of the legal basis and purposes for which we process personal data that we have collected from you or that you have provided to us when you use the 2weeks.ch platform to carry out COVID-19 rapid tests. We would also like to inform you about your data protection rights. The Graubünden Public Health Department handles your personal data confidentially and for specific purposes.

1. What is personal data?

Personal data is information relating to a specific or identifiable natural or legal person. Personal data that, when processed, presents a particular risk of infringing fundamental rights, such as details about health, is considered to be personal data that is worthy of protection and subject to further restrictions.

2. Who is responsible for data processing?

3. Basis

Graubünden's Health & Safety Strategy resolution, record no. 1018/2020 dated 2 December 2020, included the decision that as part of a pilot project in the Maloja region (major tourism region), Bernina (high case numbers, particularly in healthcare institutions) and Engiadina Bassa/Val Müstair, the whole population is to be tested on a voluntary basis. This is in response to rising case numbers and also aims to get a snapshot of asymptomatic cases and introduce targeted measures. This pilot project also acts as a starting point in case more tests (in the event of case numbers rising further or faster) need to be carried out across the whole canton.

4. Purpose of web app

The government of the Canton of Graubünden has ordered COVID-19 rapid antigen tests; these will be registered and carried out, and the test results announced, using the "2weeks" web app.

5. What data will we store?

The following data will be stored when you register:

- Last name, first name
- Gender
- Date of birth
- Address
- Mobile number
- Email address

The following data will be stored once the test has been carried out:

• Test result (positive or negative)

6. Where will we store your personal data?

Personal data will be stored on a Microsoft Azure server (in the cloud) by Warebig AG, Postbox 1612, CH-8750 Glarus (operator of <u>www.2weeks.ch</u>). The server / cloud storage is in Switzerland. Your personal data is transferred and stored encrypted.

7. Who is your personal data transferred to?

Other institutions (municipalities, cantonal administration, IT service providers, Federal Office of Public Health) are involved in carrying out the tests and storing the data. They will receive the data necessary. The test result (positive or negative) will only be sent to the cantonal Public Health Department and the Federal Office of Public Health (not to the municipalities or other cantonal administration departments). Your personal data and the test result will be processed for the purpose of epidemiological analysis and sent to the government's reporting system.

8. Which marginal data will be stored?

When you use the web app, some marginal data (e.g. browser version used) will be stored and cookies used (depending on the area). For more details, see the 2weeks privacy policy:

9. How long will my personal data be stored for?

Encrypted personal data and the test result will be deleted off the coronavirus platform used to administer rapid tests once the purpose for which they were processed has been fulfilled, after a maximum of two weeks.

10. Destroying personal data no longer needed

Stored personal data will be destroyed by us as soon as it is no longer needed.

11. Your rights as the data subject

You have the right to request the following from the Graubünden Public Health Department:

- Information about your personal data that has been processed;
- Amendment of incorrect personal data;
- Deletion of incorrect personal data that cannot be corrected;
- No unlawful processing of personal data;
- Elimination of consequences of any unlawful processing of personal data.

12. Subject to change

The Graubünden Public Health Department is entitled to make amendments to the privacy policy at any time, particularly due to changes in the law through legislation or case-law. The current version can be viewed and downloaded on www.gr.ch/coronavirus.
